In lieu of the immediate completion of said landscaping, principal must submit a surety bond acceptable to St. Louis County in the amount of _____ dollars (\$_____) executed by principal and an authorized surety, such bond to be conditioned on the full and complete installation of landscaping within twenty-four (24) months after the date of approval of said landscaping plan by the St. Louis County Planning Commission.

Now, therefore, if the final and complete installation of such landscaping as prescribed and required by the St. Louis County Planning Commission pursuant to the ordinances adopted by St. Louis County shall be accomplished by principal or his successor within twenty-four (24) months of approval of said landscaping plan by the St. Louis County Planning Commission and the principal or his successor shall obtain a letter to that effect from the St. Louis County Planning Director, then this obligation shall be null and void; otherwise it shall remain in full force and effect.

If the property involved is now or shall at any time be included within the boundaries of any municipality, such municipality shall succeed to all of the rights of the County of St. Louis in this bond.

This bond may be sued on by any person injured by principal's failure to install landscaping as required herein within twenty-four months, but the total obligation herein shall be limited to the amount set forth above.

This bond is not cancelable.

Should any legal proceedings be necessary to enforce this bond, such sum as the court may determine to be reasonable shall be allowed to obligee as attorneys' fees in addition to other sums found due.
