**Missouri State Electrical License Holders Operating in St. Louis County MO.**  
**Acknowledgement Form**

Your ability to obtain permits that authorize you to perform electrical work in St. Louis County requires that you maintain your St. Louis County Electrical Account and comply with codes, rules and regulations that govern electrical work within the jurisdiction of St. Louis County. Be aware of the circumstances that can cause your account to be suspended or revoked as follows:

I understand that I am licensed by the State of Missouri in the business name of \_\_\_\_\_

I understand that I shall not use my St. Louis County electrical permits or account for a business entity of any other name and that only the employees of the business entity that appears on my State license and my account are authorized to perform electrical work authorized by a St. Louis County Electrical permit. Employees as defined in the St. Louis County Electrical Code meet the stipulations of the IRS 20 factor test. \_\_\_\_\_ Initial here

I understand that if I perform electrical work in St. Louis County under any company name other than the name on my State license and St. Louis County Electrical Account or, allow anyone other than an employee (as described above) of said company to perform electrical work on authorized by a St. Louis County Electrical permit I will be required to appear before the Board of Electrical Examiners for a hearing to determine if my account should be suspended or revoked. \_\_\_\_\_ Initial here

I understand that I am responsible for obtaining the required St. Louis County permit prior to beginning any electrical work in St. Louis County and that I am responsible for scheduling the required inspections and taking the required action to cause approval including the final inspection. \_\_\_\_\_ Initial here

Business requirements:

I understand that I must have and maintain a street addressed place of business with all necessary occupancy permits. \_\_\_\_\_ Initial here

I understand that I will have someone in attendance and on premise at the established place of business to receive calls during regular business hours or provide other effective means of communication and that all service vehicles will be identified with the company name and phone number and markings shall be at least 3" in height and 1/2" in width. \_\_\_\_\_ Initial here
