2537	6/6/62	Repeals Sections 1103.040, 1103.050, 1103.060, 1103.110 and enacting new sections relating to general regulations, materials quality and weight, joints and connections.
3357	9/17/64	Repeals Chapter 1103 and adopts the Uniform Plumbing Code in accordance with Sections 341.090 through 341.220 of Chapter 341 R.S. MO. 1959.
4154	11/28/66	Repeals sections relating to the committee of plumbing code review, permits and inspection fees, violations, general regulation, materials and methods of installation and enacted new sections relating to the same subjects.
4545	12/21/67	Amends permit and inspection fees.
4609	2/12/68	Repeals sections relating to materials, quality, mechanical joints, pipe and drainage systems and enacts new sections relating to the same subjects.
4871	11/25/68	Repeals section relating to water service pipe and enacts a new section relating to the same subject (plastic pipe).
5013	3/28/69	Repeals section relating to plumbing fixtures and enacts a new section relating to the same subject. (fiberglass tubs).

6254	3/27/72	Repeals sections relating to materials, joints and connections, traps and cleanouts, indirect waste piping, water supply and distribution, drainage systems and sanitary sewers. Enacts new sections relating to the same subjects.

6492	10/6/72	Repeals sections relating to the definition of Building Official, Office of Plumbing and Sewer Inspection, powers and duties of the Supervisor of Plumbing and Sewer Inspection, permits and inspection fees. Enacts new sections relating to the same subjects.
7099	4/15/74	Repeals sections relating to permits and inspection fees, sewer and water supply data, violations, qualifications of plumbers, definitions, materials, joints and connections, traps and cleanouts, interceptors, separators and backwater valves, plumbing fixtures, drainage systems, vents and venting, storm drains, sanitary sewers, portable water supply pumps, water heater replacement, and fire protection water taps. Enacts new sections relating to the same subjects.

8287	6/24/77	Repeals sections relating to permits and water heater replacements. Enacts new sections relating to the same subjects and including homeowner permits.
9190	5/7/79	Repeals Section 1103.090 relating to licensing and enacts new section on the same subject.
9633	2/22/80	Amends Section 1103.185 relating to homeowner permits.
10466	12/24/81	Amends license, permit and inspection fees.
10489	1/11/82	Amends permit and inspection fees.
10736	9/2/82	Amends inspection fees.
11938	2/25/85	Repeals Chapter 1103 and adopts the 1983 National Standard Plumbing Code including Appendices A, B, C, D, E and basic principals 1 through 22 and local amendments.

12163	7/18/85	Adds new Section 1103.106 regarding Temporary Emergency Licenses.
13102	2/13/87	Amends plumbing permit and inspection fees.
13714	1/29/88	Repeals Section 610.080 of Chapter 610 and enacts a new section relating to required sewer connections.
14078	9/16/88	Repeals Chapter 1103 and adopts the 1987 National Standard Plumbing code including Appendices A, B, C, D, E and basic principals 1 through 22. Includes local amendments.
15035	6/21/90	Repeals Section 1103.310 and enacts new sections relating to process piping installer registration, irrigation system installer registration, backflow preventer tester registration, and installation of backflow preventers.
16251	12/11/92	Repeals Chapter 1103 and adopts the 1990 National Standard Plumbing Code including Appendices A, B, C, D, E, F, G, and H and basic principals 1 through 22. Includes local amendments.
16341	2/11/93	Amends sections relating to licensing, bonds and insurance, variances and code interpretations.
17895	1/25/96	Repeals Sections 1103.120 and 1103.410 and enacts new sections relating to licensing, registration, certification and water supply and distribution.
18964	6/15/98	Repeals SLCRO Chapter 1103 and adopts 1997 Uniform (IAPMO) Plumbing Code including Appendices A, B, C, D, E, F (Reserved), H, L and I. Includes local amendments and added Appendix M.
19870	3/16/00	Removes fee schedule from Plumbing Code ordinance (SLCRO 1103) and places Plumbing Code fees in Chapter 1100 SLCRO "Code Enforcement Fees Schedule".
20312	12/21/00	Increased amount of Bond and Insurance coverage for Master Licensee's; charged hardship clause to address Drainlayers; added Interim Journeyman license, removed requirements for RPZ backflow prevention for Carbonators; added Drip Irrigation and Low Pressure Piping systems as acceptable for

private sewerage systems.

22338	6/1/05 (Effective 10/1/05)	Repeals/Re-enacts SLCRO Chapter 1103 and adopts 2003 Uniform Plumbing Code (IAPMO/ANSI UPC 1-2003).
24441	7/14/10 (Effective 11/1/10)	Repeals/Re-enacts SLCRO Chapter 1103 and adopts 2009 Uniform Plumbing Code (IAPMO/ANSI UPC 1-2009)
24967	12/20/11 (Effective 2/1/12)	Backflow amendment (changed only Section 1103.P-156 - This Section was changed again by Ordinance 25,573).
25573	11/06/13	Amends/Adds several administrative provisions as well as amending several sections of the code.
25617	12/04/13	Amends 2-3 sections of the code.
25715	03/05/14	Amendments/Corrections to 5 sections of the code.
27424	06/05/19	Repeals/re-enacts SLCRO Chapter 1103 and adopts 2015 Uniform Plumbing Code (IAPMO/ANSI UPC 1-2015). Effective date 10/01/19. Designs using this ordinance may be submitted under a permit application as early as 06/05/19.
